# CITY OF AMES, TEXAS ORDINANCE NO. 2025-004

AN ORDINANCE OF THE CITY OF AMES, TEXAS, CANVASSING THE RETURNS AND DECLARAING THE RESULTS OF THE GENREAL MUNICIPAL ELECTION HELD ON MAY 3, 2025; FOR THE PURPOSE OF ELECTING A MAYOR AND TWO COUNCIL MEMBERS TO THE AMES CITY COUNCIL; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, there was held in the City of Ames, Texas, on the 3rd day of May 2025, a General Election duly ordered by the City Council for the purpose of electing a Mayor and two Council Members, as shown in the official returns heretofore; and

WHEREAS, public notice of the City's Municipal Election was duly given; that said election was held in the manner required by the Texas Election Code, Texas Administrative Code, and Texas Constitution; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AMES, TEXAS:

**Section 1**. It is found and determined that the results of the General Election as canvassed and tabulated reflect the expressed desires of those persons voting at said election.

**Section 2.** That the following named candidates were duly elected at said general election to the Ames City Council:

**Section 3.** It is hereby declared the City of Ames approves and accepts the results of the General Election for the Mayor and Council Members, as set forth in "Exhibit A".

Section 4. That if any section, subsection, sentence, clause, or phrase of this ordinance should for any reason be held to be unconstitutional or invalid by a court of competent jurisdiction, such invalidity shall not affect the remaining portions of this ordinance, and to such end the various portions and provisions of this ordinance are declared to be severable; and the City Council of the City of Ames, Texas, declares it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, or whether there be one or more parts.

Section 5. It is officially found, determined, and declared that the meeting at which this ordinance is adopted was open to the public and public notice of the time, place, and subject matter of public business to be considered at such meeting was given.

Section 6. This Ordinance shall be in full force and effect from and after the date of its passage.
